



**MEMORANDUM OF UNDERSTANDING
BETWEEN
THE DIVISION OF CONTINUING STUDIES,
UNIVERSITY OF WISCONSIN-MADISON, USA
AND**



ADITYA ENGINEERING COLLEGE, SURAMPALEM, ANDHRA PRADESH, INDIA

To promote cooperation between the University of Wisconsin-Madison, the Division of Continuing Studies (DCS) and Aditya Engineering College, and desiring to expand scholarly ties, facilitate academic cooperation and promote mutual understanding, both parties agree to explore the feasibility of establishing a framework for educational and student mobility.

In preparation for establishing a formal framework for future activities, both parties will:



- Consult faculty, departments, and centers to explore potential recruitment opportunities for international mobility to UW-Madison via the non-degree Visiting International Student Program (VISP) offered through the Division of Continuing Studies.
- At VISP's lead, explore the feasibility of specific academic area activities via VISP thematic track (or special summer) programs in conjunction with UW-Madison departments; and
- Encourage the creation of VISP programs for individual or groups(s) of students to study at UW-Madison through in-person, or customized VISP or DCS affiliated programs.



If both parties agree to pursue such arrangements, visits, and other forms of cooperation will be developed for each specific case. Any commitment of resources, financial or otherwise, must be made in specific agreements to be entered into for this purpose at a subsequent date.

This MOU does not constitute a joint venture, partnership, consortium, or any other form of business arrangement or organization. Each party agrees not to use the name, trademarks or logos of the other party or the name of the other party's employees, officers, board members or agents in any way including but not limited to, in sales promotion, advertising materials, applications or proposals without that party's prior express written agreement.

This MOU expresses the basic understanding and present intentions of the parties but does not attempt to either specify or otherwise limit the collaborative efforts between the parties. It merely serves as evidence of the parties' good faith intentions with regard to the activities. Except as otherwise set forth in this MOU, the MOU does not obligate any party to enter into any other agreement, collaborative relationship, or any proposal effort.

The parties agree to consult periodically concerning the status of these explorations and other relevant matters. This memorandum will be in effect for a period of three years upon signature of both parties.
